



II. SCOPE OF WORK

Agency has to supply and install Christy made Projector lamp, Roadster S+22k-J (3.0 KW) in Bihar Museum Society, Patna with all technical assistance.

III. ELIGIBILITY CRITERIA(Mandatory)

- a) The Bidder must be a registered contractor/authorized distributor/ reputed company..
- b) Must have PAN Card and GST registration.
- c) Income Tax Return of 3 Assessment years should be submitted with the bid.
- d) There should be no case pending with the police against the Proprietor/Firm/Partner or the Company and should not be blacklisted by any Government office. (An undertaking in this regard on Non-Judicial Stamp Paper of Rs. 100 is to be provided.)
- e) Proposals of the agencies not meeting the above criteria shall be summarily rejected. Bidder must submit the signed copies of above certificate.

IV. PROCEDURE

1. Tender Bids should be placed in a properly sealed envelope addressed to **the Director General , Bihar Museum, Bailey Road, Patna - 800001.**
Bid along with Tender Processing Fee be **put up in a sealed envelope, and super-scribed "Tender for Christie made Projector lamp, Roadster S+22k-J (3.0 KW) "** with the name, address, e-mail & phone nos. of the Bidder. The tender must be submitted at the **Office of the Director General, Bihar Museum, Bailey Road, Patna - 800001** on the date & up to the time mentioned in the tender notice and the tenders will be opened in the Office of the **Director General, Bihar Museum, Bailey Road, Patna - 800001** in the presence of all Bidders or their authorized representatives.
2. The bidder must ensure that the conditions laid down for submissions of offers are complete and correctly filled. The rates and units shall not be overwritten and shall be in both i.e. figures and words.

V. TERMS AND CONDITIONS

1. The bidder must provide information about his Agency as per Annexure-I.
2. All the rates should be all inclusive, i.e. all admissible administrative charges & Taxes.
3. Defect liability Period will be one year.
4. 05 percent of bill value will be deducted which will be returned after DLP.
5. TDS and other taxes as applicable will be deducted from agency's bill as per Govt. instructions from time to time.
6. Agency will send the concerned technician to install lamp in the projector at Orientation Theatre in Bihar Museum.
7. No advance payment shall be made.
8. The Agency shall submit its bill in triplicate
9. The Bihar Museum Society shall be the sole authority to decide and judge the quality of the service rendered by the Agency and all other matters and his decision shall be final and binding.
10. In case of any dispute, the jurisdiction shall be the Court at Patna only.
